- 5. that no particular religious education shall be imparted by the institution to maintain secular character of the institution.
- 6. that the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students.
